

# **Privacy statement**

Viewfinder is committed to protecting your privacy online. We use the information we collect about you to provide services to you when you visit our website and where you have consented to the same, we will send you various sorts of information, as detailed below. We appreciate that you do not want any personal information you provide to us distributed indiscriminately so this Privacy Statement explains how we collect information, what we do with it and what controls you have. # 1. What information do we collect?

So that we can provide a personalised service, we may ask you to submit personal information such as a name, email address, postal address, telephone number, your gender and date of birth. You are under no obligation to provide such information and we will always ask you for the minimum amount of information necessary. However, if you should choose to withhold requested information, we may not be able to provide you with certain services. If you are registering specifically to hear from us, we will take this as your consent, so we will not ask you to tick 'yes' or 'no'. You are entitled to request a copy of your information (for which we may charge a small fee) to correct any inaccuracies or you may request that we delete your information.

Once you are on our database, we may also record details of any Viewfinder marketing lists to which you have subscribed or unsubscribed, mailings we have sent to you, hyperlinks you have followed in our email marketing messages and/or event invitations sent to you and your response.

From time to time we may also ask you to review your contact details and mailing list preferences to ensure that we only send you information which is relevant to you.

# 2. How is the information used?

We will use the information you provide to us to:

## 3. Where is the information stored?

Information submitted by you may be transferred to, stored and processed by our service providers and other reputable third party organisations, which may be situated outside the European Economic Area. In addition, if you use our services while you are outside the EEA your information may be transferred outside the EEA in order to provide you with those services, and by submitting your information to us you consent to such usage.

### 4. When may we contact you?

We will provide you with the right to unsubscribe to these communications as part of each such communication and at any time by contacting our Information Protection Manager whose details are set out above.

### 6. Will my information be shared?
